IN WORKING TOWARD OUR GOAL THAT ALL CHILDREN ENTER SCHOOL EAGER AND READY TO LEARN AND ACHIEVE LITERACY PROFICIENCY BY THIRD GRADE, WE ESTABLISH RELATIONSHIPS WITH LOCAL ELEMENTARY SCHOOLS AND ALIGN OUR CURRICULUM WITH THE MASSACHUSETTS FRAMEWORKS. MANY OF THE CHILDREN HAVE AGED UP FROM OTHER PATHWAYS' PROGRAMS OFFERING FAMILIES A VALUED CONTINUUM OF CARE MODEL. SERVICES ARE ALSO PROVIDED TO PRIORITY POPULATIONS INCLUDING ABUSED OR NEGLECTED CHILDREN; FAMILIES EXPERIENCING ADDICTION AND DOMESTIC VIOLENCE OR POVERTY.
